Indian solar equipment exports to the US are set for a significant boost. Companies are now planning to export higher-value items like battery storage systems and inverters. In FY 2021-22, the value of export of solar PV modules was around 83 million USD, which rose to around 1969 million USD in FY 2023-24 and in FY 2024-25 till November 2024, solar PV modules worth around 782 million US ioned at Annexure-I.
