Public utility subsidies for buying or installing clean energy property are subtracted from qualified expenses. There are federal tax credits available through the end of 2025 which empower Americans to make homes and buildings more energy-efficient to help reduce energy costs and demand. You may be able to take the credit if you. Use this tool to learn whether your electricity was shut off during a Public Safety Power Shutoff (PSPS).

Government subsidies for energy storage projects can be substantial, varying by location and project scope, and are designed to enhance grid reliability, integrate renewable resources, and support energy transition goals. Many states and utilities provide additional rebates or performance-based incentives for storage systems. These incentives reduce upfront cost and improve return on investment for home battery or portable solar generator setups; eligibility varies by size, location and installation details.

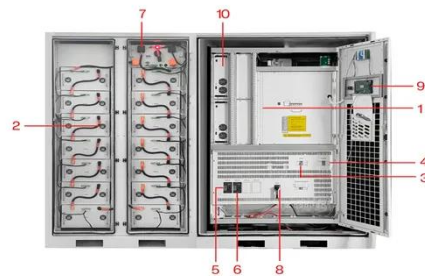
