The legal regime applicable in Portugal is Decree-Law 15/2022, which also affects renewable energy communities, making the transposition into Portuguese law of the Renewable Energy Directive (EU) 2018/2001. With around 3,000 hours of sunshine per year, Portugal stands as the European country with the highest average hours of sun exposure, and it has harnessed this advantage to emerge as one of the most progressive and enthusiastic nations in the promotion of renewable energy. Portugal's domestic carbon neutrality goals. 72 TWh of generation to the Portuguese grid, accounting for 14.9 GW in. While Portugal's revised National Energy and Climate Plan (NECP) and Long-Term Strategy for Carbon Neutrality (LTS) have raised targets for decentralised solar photovoltaic (PV) capacity, they remain below the country's solar potential. Decree-Law 99/2024 of 3 December establishes maximum deadlines for licensing and prior control procedures for renewable energy projects, including two years for production and operating licences (three years for offshore projects) and reduced deadlines for prior registrations and retrofits.



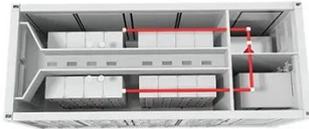
